# **Privacy Policy**

This Privacy Policy ("Policy") applies to lotusnaples.com, and Lotus Construction, LLC. ("Company") and governs data collection and usage. For the purposes of this Privacy Policy, unless otherwise noted, all references to the Company include lotusnaples.com. The Company's website is a Company Information site. By using the Company website, you consent to the data practices described in this statement.

### **Collection of your Personal Information**

We do not collect any personal information about you unless you voluntarily provide it to us. However, you may be required to provide certain personal information to us when you elect to use certain products or services.
